International Leadership of Texas Private High School - Garland **Admissions and Enrollment – Fall 2019**

ILTexas Private High School - Garland is certified by the Student and Exchange Visitor Program (SEVP) to accept F1 international students. It is critical that all procedures and policies are followed to properly enroll international students on an F1 visa. ILTexas Private High School will take the necessary steps to ensure procedures are followed correctly and students are maintaining status.

Please note, all application documents must be translated into English and uploaded or returned to the Admissions Office by Monday, July 15, 2019, to be considered for acceptance for the Fall 2019 semester. Please submit all documents to info@iltexasglobal.org.

Options for Attending ILTexas Private High School Garland for the Fall 2019 Semester:

Option 1:

Boarding School Option

Students live on-campus in student apartments

Option 1 Cost*: \$40,000

Option 2:

Day School Option

Students are responsible for finding their own housing in the Garland/Dallas area

Option 2 Cost*: \$29,000

**Students who do not meet the minimum English requirements will be required to be enrolled in additional English as a Second Language (ESL) classes after school. The cost for the additional classes is \$2,500. The total tuition amount is \$42,500 for Option 1 and \$31,500 for Option 2. Students will be notified of this requirement in their acceptance letter.*

FINANCIAL DOCUMENTS:

- ☐ **Bank Statement or Bank Letter from your sponsor with a minimum of \$40,000 for Boarding School students and Day School students as an evidence of sufficient support for one full school year.** Must provide a recent bank statement issued within the last 6 months.

APPLICATION FEE:

- ☐ **A \$100 non-refundable application fee is due at time of application**

INTERVIEW:

- ☐ **English Interview with ILTexas Staff** (After you pay the application fee, you will receive an email with instructions on how to set up a time for your interview. All interviews will be conducted online via FaceTime, Skype, or WeChat. Students who fail the interview will be required to take additional ESL classes after school for a fee of \$2,500 per year or \$1,250 for the Spring semester)

TRANSFER STUDENTS: (only for students currently studying in the United States)

- ☐ **Transfer Request Form** (Required only for students transferring their I-20 from a U.S. school)

I-20:

Once all of the documents listed above have been received, the application has been processed, and the applicant has been accepted, a Certificate of Eligibility Form I-20 will be issued and mailed to the address provided on the application.

TUITION FEE:

- ☐ **Option 1: Tuition Fees Payment for Boarding School students - \$40,000 due July 22, 2019**
- ☐ **Option 2: Tuition Fees Payment for Day School students - \$29,000 due July 22, 2019**

Application Review and Acceptance

International students wishing to attend ILTexas Private High School must complete the application process and be accepted to the school. After all of the documents listed on the checklist have been collected, ILTexas Private High School - Garland will review the submitted documents and determine acceptance.

Admitted students will then receive an acceptance letter via email detailing the student's program start date, grade level, and expected graduation date. ILTexas Private High School will issue and mail a Certificate of Eligibility Form I-20 and Welcome Packet after the student is accepted.

The student must commit to attending ILTexas and pay the remaining tuition and fees amount for the Fall 2019 semester by July 22, 2019.

The I-20 Welcome Packet will include:

- New Student Checklist (important documents that must be brought to ILTexas)
- ILTexas Acceptance Letter
- Signed Certificate of Eligibility Form I-20 (transfer students may not receive an I-20 until after the former school transfers the I-20 to ILTexas Private High School Garland)
- Power of Attorney Form to be Signed and Notarized. (Only for Boarding School students. **Please note**, this can be done at the Consulate or Embassy. A separate appointment is required.)
- Vaccinations Required for the 2019-2020 School Year
- Health Insurance Information
- Steps on Obtaining an F-1 Visa and paying the required I-901 SEVIS Fee
- Tuition and Fees Invoice

Students are responsible for obtaining their F-1 Visa. The following is necessary before applying:

- Pay I-901 SEVIS Fee online at www.fmjfee.com and retain the receipt
- Complete the Visa DS-160 Form and retain the receipt
- Schedule an interview at the U.S. Consulate or Embassy

It is important for students to bring the following when interviewing for the F-1 Visa:

- Student Passport
- Legal Guardian's Passport
- Certificate of Eligibility Form I-20 signed by PDSO, Student, and Legal Guardian
- Signed Statement of Financial Evidence Form and Proof of Funds
- DS-160 Visa Application Receipt
- SEVIS Payment Receipt
- ILTexas Acceptance Letter
- Power of Attorney Form for notarization (a separate appointment must be made by the parents)

Once the student has completed the requirements above and received a student visa, notify the International Student Department at info@iltexasglobal.org.

Late Admission / Late Arrival

Admission after the application deadline will be allowed on a case-by-case basis. Students must submit all required admission documents and must provide an anticipated start date. Late Arrival students are expected to submit their most recent academic transcripts. Full semester credit cannot be guaranteed if the student is arriving late.

Meal Plan

Students have two options for meal plans for breakfast and lunch on instructional days. Students must choose a meal plan by July 22, 2019 and will not be able to change their meal plan after this day. No refunds will be issued for any meal plans.

Meal Option A: School Prepared Breakfasts and Lunches – prepared by the cafeteria workers

Meal Option B: Chef Prepared Breakfasts and Lunches – prepared by the ILTexas Global chefs on Sunday-Thursday nights and distributed to the students at the student apartments in the evening. Students take their lunch to school.

Refunds

No refunds of any kind will be issued for any reasons that fall outside of an F-1 visa rejection. Once a student is enrolled in ILTexas, there will be no refunds given for any reason.

English Proficiency Tests

English Proficiency Tests are highly encouraged for proper class placement and to determine whether additional ESL will be required. Please submit TOEFL, TOEFL Jr., or IELTS test score results with your application if available. TOEFL Institution Code: B318. Please submit all English Proficiency Test Results to info@iltexasglobal.org.
